

Mental Illness and Personality Disorders Case Files

Task:

You will research and create a fictional yet realistic mental health case file. You will be creating a patient and their medical case file - Showing your research and understanding of your chosen mental health illness or disorder.

Your research must include the following:

- Description of Disorder
- Symptoms of Disorder
- Who is most likely to be afflicted with the disorder
- Causes of the Disorder
- Case Report
- Treatment of Disorder
- Interesting facts, figures and statistics
- Chicago Bibliography

Case Files

Your case file must include the following:

- A picture of the individual (fictional) (avoid recognizable pictures)
- A file folder, label like in a medical office
- A short biographical fact file (e.g. name , age sex, marriage status, race, height, weight) **etc**
- A one page at least description of the first episode or symptoms of the disorder. The reason why they came to the doctor's office.
- A one page at least report indicating your diagnosis based on their information and the symptoms shown-you must also include a treatment approach. (e.g. drugs, therapy etc)
- The report should also include the above bullets
- Bibliography 7+ sources (at least one book – other than your textbook)

Panic disorder, Generalized Anxiety Disorder, Phobias, Posttraumatic Stress Disorder, Amnesia, Depersonalization Disorder, Multiple Personality Disorder, Hypochondriasis, Personality Disorder, Impulse Control Disorders (Kleptomania, Pathological Gambling, Pyromania), Mood disorders, depression, bipolar, suicide, Autism, ADHD, Oppositional Defiant Disorder, Conduct Disorder, Tourette's syndrome, or another disorder with approval by your teacher.
